

# **SUMMARY ANNUAL REPORT**

## **For Ursinus College Defined Contribution Retirement Plan**

This is a summary of the annual report for Ursinus College Defined Contribution Retirement Plan, EIN 23-1177930, Plan No. 001, for period January 01, 2020 through December 31, 2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **Basic Financial Statement**

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$8,758,065. These expenses included \$33,959 in administrative expenses, and \$8,724,106 in benefits paid to participants and beneficiaries. A total of 903 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$124,192,232 as of December 31, 2020, compared to \$115,225,841 as of January 01, 2020. During the plan year the plan experienced an increase in its net assets of \$8,966,391. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$17,724,456, including employer contributions of \$932,771, employee contributions of \$1,940,689, rollover contributions of \$992,799, earnings from investments of \$13,831,308, and other income of \$26,889.

The plan has a contract with Tiaa-Cref. The total premiums paid for the plan year ending December 31, 2020 were \$0.
